

GAPPS Membership Application Form

Membership Information

The Global Alliance for Project Performance Standards (GAPPS) is a volunteer organisation that provides a forum for stakeholders from differing systems, backgrounds, and operating contexts to work together to address the needs of the global project management community.

Membership of GAPPS is an opportunity to support, contribute to and influence the agenda for development of frameworks that facilitate mutual recognition and global transferability of project management standards and qualifications. A Member of GAPPS must be an organisation and cannot be an individual. Where a member is an Association or organisation any nominated staff member or volunteer of that organisation may be considered as a representative of that organisation.

The formal conditions for the admission to membership are:

- Member organisations commit to recognising assessment findings against GAPPS framework made by other endorsed organisations in line with the Constitution and Membership guidelines
- Agreement to abide by the GAPPS Code of Conduct as set out in the By-Laws of the GAPPS constitution

Members of GAPPS are entitled to:

- The use of the GAPPS Member logo in line with the usage guidelines
- Ability to have representatives attend Working Sessions at membership rate
- Contribute to development, creation and maintenance of standards through attending Working Sessions
- Contribute to administration of GAPPS through boards/chairs/committees
- The opportunity to host Working Sessions
- Have a link provided to their organisation on GAPPS website
- The opportunity for knowledge sharing with other members

An organisation's admission as Member will only become valid on payment of the first year's membership fee, and will lapse if that is not paid within three months of the Council meeting at which membership was approved.

Members shall be free to withdraw from GAPPS at any time. No refunds of membership fees will be paid even in the instance where withdrawal occurs part way through the first financial year of membership.

No personal financial liability shall exist in respect of the commitments of being a GAPPS member.

Admission of an organisation to Membership of GAPPS is subject to Approval by the GAPPS Board.
